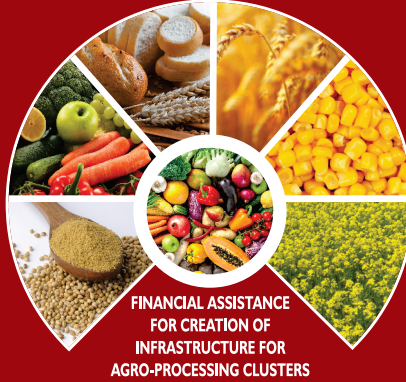

Ministry of Food Processing Industries invites proposals / Expression of Interest (EoI) from potential promoters / investors for setting up of 60 Agro Processing Clusters near the identified agri-horti production clusters in the country. The willing investors may submit their proposals through **online portal** (<http://sampada-mofpi.gov.in/cluster/Login.aspx>) only as per the operational guidelines for the Scheme for Creation of Infrastructure for Agro Processing Clusters dated 07.07.2017. The detailed operational guidelines of the scheme and an indicative list of identified agri-horti production clusters (fruits & vegetables) are available on Ministry's website: www.mofpi.nic.in (Schemes → Agro Processing Clusters → Guidelines) and (Schemes → Agro Processing Clusters → list of identified agri-horti production clusters) respectively.

A wait list of the eligible proposals may also be prepared to be considered against vacancies / up-scaling of the scheme, if any, in future.

The proposals / EoIs, addressed to Shri Atul Saxena, Director, Ministry of Food Processing Industries, Panchsheel Bhawan, August Kranti Marg, New Delhi-110049 shall be submitted **online** only on or before **15.09.2017 by 5:00 PM**. No physical mode for submission of proposal shall be accepted.

The applicant may make online payment vide RTGS/NEFT of Rs. 1,00,000/- (Rupees One Lakh Only) towards Earnest Money Deposit (EMD/Bid Security) against account number – 3516103454, IFSC code – CBIN0282169 (Central Bank of India, Udyog Bhawan, New Delhi) of “**The Pay & Accounts Officer, Ministry of Food Processing Industries**”, New Delhi.

After selection of the suitable applicants, the amount of EMD will be refunded to the unsuccessful bidders. The EMD of the successful bidders shall be retained by the Ministry as Performance Security till the completion of the project. The amount of EMD retained as performance security shall be forfeited in the event of non-completion of the project or withdrawing from the project after according approval.

Pre-bid meeting for interested stakeholders will be held on 21.08.2017 at 3:00 PM in Room No. 120, Ministry of Food Processing Industries, Panchsheel Bhawan, August Kranti Marg, New Delhi.
