
"Welcome to AP Sand Sale Management & Monitoring System.
Consumers are invited to register themselves on the portal for online booking of sand. Based on their requirements Consumers have been classified into 2 categories -
General Consumer and **Bulk Consumer**
Kindly go through the following steps for more details on classification, eligibility and procedure to register & order sand as per your requirement in a seamless manner."

	General Consumer	Bulk Consumer
Definition	Any individual who intends to purchase sand for domestic/personal use, such as construction of personal house, repairs etc. is classified as "General Consumer".	All other categories of consumers, who are not classified as "General Consumer" shall be classified as "Bulk Consumer". this will include real estate developers, private contractors, Government departments and similar large consumers of sand.
Maximum permissible quantity	A "General Consumer" is eligible to purchase a maximum quantity of 500 metric tonnes of Sand in a period of 12 months, provided the required sand quantity is certified by relevant authorities. (Refer "Procedure for Ordering Sand" for more details).	There is no Maximum Permission Quantity which can be purchased by Bulk Consumers. However, Bulk consumers need to get their required sand quantity certified by competent authorities. (Refer "Procedure for Ordering Sand" for more details).
